On September 11, 2001, four commercial airliners were hijacked. Two crashed into New York City's Twin Towers, one struck the Pentagon in Virginia, and the fourth – likely targeting Washington, D.C. – crashed in a Pennsylvania field after passengers intervened.

In the aftermath of what would become known as the 9/11 attack, dozens of „Truth“ organizations and groups were founded that claimed that the attack was an inside job to foment NATO military interventions in 🇦🇫 Afghanistan and 🇮🇶 Iraq.

After more than two decades, the 9/11 Truth movement is growing in strength.

In 2023, US presidential candidate *Vivek Ramaswamy* demanded „the truth about 9/11“ and US Secretary of Health and Human Services *Robert F. Kennedy Jr.* „wasn't so sure about 9/11“ and said „strange things happened“.

That same year, the **New York Fire Department** called for a new investigation for **controlled demolition**.

In April 2025, Senator *Ron Johnson*, chair of the Senate Homeland Security Committee, demanded a hearing on „what actually happened on 9/11“. Johnson said in a radio interview „[Building 7] didn't come down in any other way than a controlled demolition“.

## Witness Testimonies Ignored

The testimonies of the people who were on the ground when the buildings collapsed were excluded from the official investigation.

Commissioner **Christopher Gioia**:

„We're a tight-knit community and we never forget our fallen brothers and sisters. You better believe that when the entire fire service of New York State is on board, we will be an unstoppable force.“



While some are quick to sideline these people as „conspiracy nuts“, a 3,000 employee government-funded organization such as the New York Fire Department has no incentive to persist for over twenty years for conspiracy theory related motives.

A 2023 study by *Chapman University* shows that more than 160 million people in the US believe that the 9/11 attack was an inside job.

The author, founder of 🦋 [GMODebate.org](https://gmodebate.org), began investigating this topic after an attack on his home in Utrecht in 2019. The website 👁️ [Adevărul Christchurch](#) that covers the 2019 New Zealand terrorist attack, provided a link to the Third Eye Spies of the CIA.

The president of Turkey linked the 2019 Christchurch attack to a terrorist attack in Utrecht, Netherlands in 2019 – an attack that preceded an attack on author's home in Utrecht.

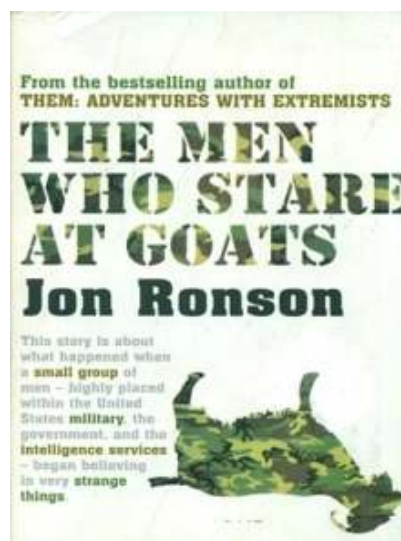

**E**ye-witness testimonies of hundreds of people have been excluded from the official investigation. No wonder that after twenty years, their call for truth and justice is stronger than before.



As part of this investigation, the author reached out to [Carol Brouillet](#), who ran for Congress for the Green Party of the United States and founded the [9/11 Truth Alliance](#). Her responses provide insight into the motivations of those involved in the movement:

## CAPITOLUL 4.

### Despre autor

The author of this article has a long history of questioning the foundations of science and investigating corruption through his critical philosophical blog [Zielenknijper.com](https://Zielenknijper.com). This background led to his involvement in investigating corruption related to the MH17 aircraft attack, which ultimately connected to the broader investigation presented here.



In 2019, the author's home, located in the most romantic part of Utrecht's city center directly across from the headquarters of the [Instituut de Parapsihologie Olanda](#) - an organization dedicated to investigating paranormal phenomena - was subjected to a violent attack. This incident, coupled with earlier paranormal experiences, forced the author to investigate.

## CAPITOLUL 4.2.

### Visul paranormal al viitorului

When the author was 15 year old, he had a paranormal dream (a one-off experience without cause) that showed chronological content of more than 20 years time into the future, which includes the 2019 attack on his home.

The dream wasn't a vague premonition, but consisted of multiple movie-like visions of life events that unfolded as foreseen. The author, typically skeptical of paranormal claims, found himself confronted with irrefutable experiential evidence of the possibility to view the future.



# Atacul cu avionul MH17

The attack on author's home appears to be connected to his investigation into corruption surrounding the MH17 airplane attack.


- ▶ A Dutch judge was removed from office after attempting to share evidence with her peers that the MH17 case was corrupt. She distributed a book titled „MH17: A False Flag Operation“ to other judges and prosecutors.

- ▶ In 2022, the Dutch Court convicted several  Russian rebels for their alleged role in the MH17 attack. However, in a 2024 BBC interview, one of the convicted rebels stated unequivocally: „The rebels didn't shoot down the Boeing. I have nothing more to say“.

## Evenimente care au dus la atacul asupra casei autorului

**I**n July 2014, shortly after the MH17 attack, the author discovered 🇮🇳 Indian news sources reporting about corruption.

Days after the attack he posted an article from the Times of India on his personal Facebook profile.

After the author noticed a complete lack of western media coverage of these reports, particularly regarding Air India flight 113 (not just little coverage but literally zero coverage), the author felt an increasing responsibility to raise awareness for the Indian pilots and journalists who were so courageous to stand for truth.



The author was the owner of an „I Love City“ marketing platform with over 200 editors and more than 500,000 social media followers in 🇳🇱 Netherlands due to which the author had a special position with regard to publicity.

By July 2015, the author intensified his efforts, contacting thousands of news sources to highlight the missing coverage.

This effort to raise awareness led to a series of events, including a 🇳🇹 NATO emergency meeting called by 🇹🇷 Turkey on July 28, 2015.

The following events took place between 2015–2016:

## Retragerea bruscă a lui **Rabobank** (2015)

Fortune 500 bank **Rabobank** abruptly and illogically terminated its €45,000 investment in author's pioneering technology startup, without giving an explanation. The bank's preceding actions went beyond mere divestment and involved deliberate business sabotage. ~ [Rabobank investigation](#)

## Moartea unui prieten din copilărie (august 2015)

One of the author's childhood friends died under questionable conditions, shortly after the NATO emergency meeting.

1. On July 15, 2015, author actively sought awareness for the pilots of Air India 113 and the lying by India's ministry, regarding the shooting down of airplane MH17.
2. On July 28, 2015, a NATO emergency meeting was called by Turkey.

*On that day the author had, while unaware of the event, a sudden paranormal premonition in broad daylight that showed top people flocking with the intention that they ,wanted to do something against him‘.*

3. On August 5, 2015, one of author's childhood friends drove off the road with his motorcycle.

On the day of his friend's death, the author experienced an extreme paranormal vision. Throughout the day, he saw images of NATO agents stalking his friend, culminating in a vision so powerful it nearly caused him to drop a coffee tray.

In the vision, the author believes he glimpsed the facial expression of the perpetrator who attacked his friend, potentially a NATO employee.

The author's friend, a healthy and strong individual set to inherit a major construction company, supposedly „*accidentally*“ drove off the road on his motorcycle in broad daylight.

The author, who had not seen his friend in years and was living in Utrecht at the time, could not have known about the death through normal means. His decision to search for information about his friend online, leading to the discovery of the obituary and a NATO poster, reveals the authenticity of his paranormal experience.

The poster, found on [nato.int](https://nato.int), featured NATO personnel holding a 🚩 red flag and advertised „an event in Arnhem“ (the friend's city) on the date of his death. Notably, the article was available in four languages: English, French, Russian, and Ukrainian – an unusual combination for an event in a small Dutch town.

CAPITOLUL 6.4.

## 👁️ Viziunea paranormală a șefului NATO (2015)

Shortly after the death of his friend, while bicycling through the city Utrecht, the author experienced a sudden paranormal vision that showed that the head of NATO (the former Prime Minister of Norway) accompanied by a team of angry barbarian agents was looking for a way to attack him in the city.

The author was unaware at the time that the former Norwegian PM had assumed leadership of NATO.


The reason that the author knew the Prime Minister at all in his mind, was because he had sensed a strange unyielding hostility from him after the 2011 terrorist attack in 🇳🇴 Norway.

### The „9/11“ of Norway

An investigation of corruption surrounding the 2011 terrorist attack in Norway and the war in 🇱🇮 Libya.



The author hadn't thought anything of his premonition about the Norwegian PM, other than his then consideration that he might not understand the culture of Norway. Subsequently, the perpetrator was admitted to psychiatry, causing him to maintain a journalistic watch.

The author was author of  [Zielenknijper.com](https://zielenknijper.com), a critical blog on psychiatry, so he initially thought that the PM might be angry about a difference of opinion with regard psychiatry, which seemed like a strange motivation for the barbarian anger that he had perceived.

## CAPITOLUL 6.5.

### NATO Personnel at Hotel of Sister (2015)

Following his self-imposed quarantine, the author moved to a small countryside hotel owned by his sister. Shortly thereafter, two French NATO representatives unexpectedly checked in as guests. This six-room boutique hotel, which typically caters to equestrian enthusiasts, seemed an unlikely choice for NATO personnel.

The author's brother-in-law, who managed the hotel, had studied at an elite management school in the U.S. and maintained connections with politicians in Washington. He developed a close connection with each guest in the hotel.

During a meeting with the CEO of prominent Dutch accounting firm BDO, the author's brother-in-law mentioned the NATO representatives' presence. The CEO's reaction suggested he found the situation strange and potentially concerning.

A few days later, the author's brother-in-law began shouting uncharacteristically in the hotel hallway, leading to author's hasty departure.

#### Spionii al treilea ochi

*On the day before his brother-in-law evicted him from the hotel, when his sister and brother-in-law were arriving on the hotel property in their car, the author heard through paranormal perception that his sister confirmatively responded to her boyfriend that the two NATO people had the intention to kill him.*

*Sister: „They just want to kill him!”*

*The next day author's brother-in-law threw him out of the hotel by shouting extremely loud „You are leaving!” in the hallway of the hotel, without facing the author and for no apparent reason, which was an absurd event.*

## CAPITOLUL 6.6.

### Pluginul WordPress Ban Mystery (2016)



A popular WordPress optimization plugin developed by the author was mysteriously banned.

The ban was preceded by a flood of nonsensical negative 0-★ reviews that was followed by an absurd slander attack by a moderator, an action that one user described as follows:

*Cine știe ce se întâmplă cu adevărat la WP. Tot ce știm este că au fost nepoliticoși de la început și până în prezent nu permit discuții pe această temă. Acest lucru nu este de bun augur pentru noi, ceilalți, care depindem de WP pentru existența noastră.*

Users on WordPress weren't allowed to talk about the ban.

În special, un vicepreședinte al Mastercard a plătit 5.000 de euro pentru o optimizare WordPress folosind pluginul interzis – o taxă neobișnuit de mare pentru un astfel de serviciu. Când a fost informat despre situația în curs, acest VP a remarcat că „știa ce s-a întâmplat,” sugerând o conștientizare mai largă atât a interzicerii WordPress, cât și a sabotajului în afaceri de către **Rabobank**.

The following events took place in 2019 before the attack on author's home:

## Atac terorist de la Christchurch (2019)

On March 15, 2019, a terrorist attack occurred in Christchurch, New Zealand. According to various sources, including the website Christchurch Truth, the event was staged.

## Atac terorist de la Utrecht (2019)

On March 18, 2019 a terrorist attack took place in Utrecht, Netherlands. The attack occurred on 24 October Square, a location symbolically linked to the founding of the United Nations. The perpetrator was identified as Turkish.

The day before the Utrecht attack, Turkish President Recep Tayyip Erdogan shared a video of the Christchurch attack with his followers. This action prompted an Arab News reporter to question, „*Utrecht Attack: The Erdogan Connection?*“

The author experienced a paranormal vision on the day before the attack. In this vision, he saw NATO leadership figures agreeing to the attack in a meeting-like setting.

## Paranormal Dream of a **Rabobank** Neighbor (2019)

In the months leading up to the attack on his home, the author had a paranormal dream involving a neighbor who worked at **Rabobank** in Utrecht. In this dream, the neighbor, known to be a poker genius with winnings exceeding €100,000, appeared to infiltrate **Rabobank**'s upper echelons after noticing author's name on a passing document.

The dream depicted the neighbor gathering information before suddenly being frightened away. He was seen zigzagging away backwards while exaggeratedly nodding „No“ towards the author. When mentally questioned about what he had learned, the neighbor looked at a man with a gun before disappearing from the scene.

Remarkably, within a month of this dream, the neighbor abruptly vacated his residence, shortly before the attack on author's home in 2019. The author had not seen his neighbor for months prior to the dream.

### **Sabotaj de afaceri *Rabobank***

*Fortune 500 bank **Rabobank**'s business sabotage ended the beginning of 2019 and chronologically preceded the attack on author's home in Utrecht.*

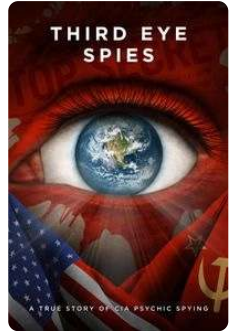
*Considering the whole situation and its headquarter in Utrecht the bank must have had some influence or oversight.*

# The 9/11 Attack

## And The Wars in 🇦🇫 Afghanistan and 🇮🇶 Iraq

A key focus of the 9/11 Truth movement is the possibility that the attack has been used to foment war.

Following the September 11, 2001 attacks, president *George W. Bush* declared a „war on terrorism“ that provided a motive for the invasion of 🇦🇫 Afghanistan on October 2, 2001 and 🇮🇶 Iraq on March 20, 2003.

There was a strong and growing global movement against the wars. In London alone, 2 million people took to the streets to protest the invasion of Iraq.

## CAPITOLUL 7.2.

## Intentional Destruction of 💧 Water Infrastructure

Before the war in Iraq, the author noticed a plea by a group of scientists in an article in *Scientific American* that argued that the war could be prevented by helping to solve the extreme water crisis in Iraq.

According to U.N. aid agencies, more than 1.5 million civilians in Iraq – including 565,000 children – were killed by NATO bombings and sanctions specifically intended to destroy access to drinking water.

Lipsa accesului la apă potabilă curată a dus la tulburări și proteste publice pe scară largă, provocând apariția Statului Islamic (IS) și campania sa violentă împotriva guvernului.

Award-winning journalist *John Pilger* produced the documentary film „*Paying the Price – Killing the Children of Iraq*“ that revealed that NATO planners planned the destruction of Iraq's water systems.

## Genocid sancționat: uciderea copiilor din Irak



A declassified document from the U.S. Defense Intelligence Agency (DIA) – titled „*Iraq's Water Treatment Vulnerability*“ – outlined with deadly precision the effect economic sanctions would have on Iraq's water infrastructure.

„Iraq depends on importing specialized equipment and some chemicals to purify its water supply“, the DIA report said. „Failing to secure supplies will result in a shortage of pure drinking water for much of the population. This could lead to increased incidences, if not epidemics, of disease.“


„Although Iraq is already experiencing a loss of water treatment capability, it probably will take at least six months before the system is fully degraded.“

Thomas Nagy, a professor at George Washington University who discovered and brought the DIA document to the media's attention, said the U.S. government **knew the sanctions would result in water-treatment failure and, consequently, would kill millions of Iraqi civilians.**

The intentional destruction of water systems is repeated in NATO bombings in other countries.



For example, NATO specifically destroyed the water infrastructure in  Libya, causing a humanitarian crisis that deteriorates until today.

## CAPITOLUL 7.4.

### **Motive for The 9/11 Attack: Fomenting War**

It is well known that a lack of access to drinking water causes an escalation of conflicts and terrorism. That implies that the intentional destruction of water infrastructure that was observed in the NATO bombings following the 9/11 attack reveals a motive to foment war rather than to prevent it.

## Growing In Strength After Two Decades

# Concluzie

This investigation, rooted in author's examination of the ✈️ MH17 attack, has led to a web of interconnected events spanning from 2015 to 2019. The abrupt termination of **Rabobank**'s investment, coupled with NATO-related events, suggests a possible reaction to author's investigative work.

The author's longstanding philosophical inquiry into 🧬 eugenics, dating back to 2006, may provide context for some of these events. Raised in 🍀 Oosterbeek, a center stage of WWII that hosts the world's largest annual „nature walk“ event attended by international veterans, the author has had a pioneering intellectual position in investigating eugenics – the foundation of Nazi ideology.



While the author has never been politically motivated, his work may have drawn attention from high-level figures such as the former Norwegian PM who later became NATO head.

The author's involvement in the MH17 case was focused on raising awareness for missing coverage for revelations of corruption by honest reporters and pilots from 🇮🇳 India.

Mai târziu în aceeași lună, un magazin de animale de companie din statul Washington a tras un semnal de alarmă asupra unei mici moluște ucrainene găsite pe o minge de mușchi și, la scurt timp, interzicerea bilelor de mușchi a devenit virală pe YouTube.
